

CALGARY ALBERTA RADIO CONTROL AUTO RACERS RELEASE OF LIABILITY FORM

DESCRIPTION OF RISKS

I am aware of, agree and acknowledge that:

1. I have been fully informed of the risks and hazardous involved in the activities or events sponsored or conducted by Calgary Alberta Control Auto Racers (hereinafter the "Club") which may result in accident, loss, damage, injury, death or expense, including such risks and hazards that may result from any maneuver, whether difficult or not, or defective equipment or property;
2. I will take all appropriate care and caution in my activities to avoid or minimize the risk of injury to me and to others, and to monitor and moderate actions to avoid injury or death to me and to others;
3. I am solely responsible for my own safety, including my equipment and property, and to take every precaution while participating in activities or events sponsored or conducted by the Club, including inspecting all equipment and property to ensure it is safe and free from all defects and in good operating condition;
4. I understand that there are no professional or certified trainers, spotters, or catchers and that a reasonable person would probably not participate in the activities or events of the Club;
5. I understand that there is no insurance coverage for the Club or any of the equipment or property and that I have represented to the Club that I have my own insurance in full force and effect. I understand that I am responsible for any and all accident, loss, damage, injury, death or expense for any and all claims;
6. I have read and agree to abide the Rules, Regulations, bylaws and Codes of Conduct established by the Club, and to follow all rules established by the Owners for activities on its premises; and
7. I grant permission to the Club to take and use photographs, and visual/audio images of myself for any legal purpose. Visual/audio images include any type of recordings, including photographs, digital images, drawings, renderings, voices, sounds, video recordings, audio clips or accompanying written descriptions. I grant this with the understanding that the Club will not materially alter the original images. I also waive my rights to inspect or approve finished images or electronic matter prior to publication and waive compensation for their use.
